Lot Purchase

Association members voted to authorize the Board of Directors to purchase a lot. Fifty-eight members voted, however, 2 ballots were not counted. One of the 2 ballots voted yes and no and the other ballot, although signed, failed to make a choice. Of the 56 remaining ballots, 37 voted to approve the purchase, 19 voted against a purchase. Clouding the issue was the fact that 3 of the yes ballots added a contingency to their response. For example, a yes vote "if the lot selected will abut the current storage area." To be fair, those 3 votes could not count as yes votes because the Board could not promise to meet the required contingency. The Board then went into a lengthy discussion. Some members questioned the authority of the Association to make a purchase even with membership approval. Others questioned the ability to pay for the lot and meet Reserve requirements. The need for a lot and the functions the lot would serve were also discussed. During the course of discussions, it became apparent that the acrimony over the issue was causing divisiveness. The Board then voted to table the lot purchase issue until the new Board meets in December. In my opinion, the lot purchase issue is dead.

Golf Cart Issue
