K.UNFINISHED BUSINESS

Question was raised as to whether additional roads are ready to turn over to VDOT? Ray Dameron will secure quotes from contractors regarding minimally maintaining surface for now and whether clearing gullies is necessary.

John Henbest will investigate HOA insurance coverage regarding whether every contractor must have their own liability coverage. Farm Bureau doesn't offer only liability but will cover if contractor lies. Three-man contractor company does not require workers comp. Mr. Harris, the grass cutter, does not have workers comp, but has liability. HOA pays liability \$200/year. VA State will pay workers comp liability and then go after us. BLHOA should pay workers' comp. BLHOA should screen contractors and not hire them if they do not have workers' comp. Joe Thompson will look into whether other HOAs have workers' comp.

Proposal to update current bylaws, integrating Northumberland County regulations, regarding golf carts, dog leash requirements and our BLHOA nominating process. Proposal to put these issues into the bylaws will take the entire BLHOA vote, so at least for now, notification can be included in any immediate disclosure packages. A simple cleanup of the bylaws should be done.

Expenses for BLHOA homeowners were addressed. John Henbest will supply a sheet of statistics of expenses to any homeowner with questions.

L. NEW BUSINESS

Summer picnic attendance was a concern. Low attendance may have been due to heat. Suggestion to combine spring cleanup with the summer picnic or to hold the picnic second week in September. No vote, item tabled.

Note was made of NAPS Distinguished Citizen Award was given to BL resident Greg Haugan. BL resident Myrtle Phillips received it last year.

Road repair was addressed. Question was to do makeshift repairs or complete resurface. Ray Dameron will contact VDOT as to what is required before BLHOA turns over roads with three or more homes. Construction companies always seem to damage the roads. An item should be placed in the covenants for the contractor to repair what they damage. For instance, the contractor should put up a bond.

Col. Phillips and Bill Hallman will address the problem regarding hunting season issues. For instance, dogs running through BL and hunters parked at the end of the road with loaded guns.

Col. Phillips and Bill Hallman will also address disaster planning. This should include more than hurricane preparedness. Teams should be organized, area cleanup, EMT training, defibrillator on site, incident commander should be trained. Mallard Bay guidelines are a place to start. Elaine Moore will assist.

M. SUMMARY OF ACTION ITEMS

ACC to meet elect chairperson; Ray Dameron will confer with VDOT re: roads; John Henbest will investigate contractor workers' comp/liability issues; Col. Phillip, Bill Hallman and Elaine Moore will research and prepare emergency preparedness plan for BL.
